The purpose of the research study is to learn what readers find useful in the *Reference Guides to Rhetoric and Composition Book Series* through WAC Clearinghouse, including: to generate topic ideas; to gain ideas for how to more equitably to narrate key topics in the field without reproducing historical biases and exclusions; and in doing so, to generate interest in the series and recruit new authors who are interested in narrating alternative syntheses of the field. There are no known risks, benefits, or compensation, although we are offering mentorship opportunities for prospective authors at the conclusion of the survey.

Your responses will be strictly anonymous. The responses will be used to help the editorial board make decisions for future directions of the book series and may be used in future research papers or presentations.

Your information collected as part of the research could be used for future research studies or distributed to another investigator for future research studies without additional approval from you.

The decision to participate in this study is voluntary and the decision is entirely up to you. You may refuse to take part in the study at any time without affecting your relationship with the investigators of this study or the University of Rhode Island (URI). Your decision will not result in any loss of benefits to which you are otherwise entitled. You have the right not to answer any single question, as well as to withdraw completely from the survey at any point during the process.

You have the right to ask questions about this research study and to have those questions answered by me before, during or after the research.
